

Information on data processing pursuant to art. 13 EU Regulation 2016/679

We inform you that, pursuant to EU Regulation 2016/679 (infra: "**Regulation**"), your Personal Data will be processed by Voihotels SpA with registered office in Via Lugaro, 15 - 10126 Turin (TO), as owner of the treatment ("**Owner**").

The Data Protection Officer can be reached at DPO@voihotels.com.

The Data Controller will process your personal data (art. 4.1 of the Regulation) for the following purposes:

- **Management of your availability and/or booking request and telephone contact (voice or text) or email, in case of need related to it**

The object of the treatment could also be particular categories of personal data pursuant to art. 9 of the Regulation (e.g. customer with disabilities), in which case the legal basis of their treatment will be your explicit consent to the treatment pursuant to art. 9.2.a) of the Regulation. If the particular data refer to minors, the explicit consent to the processing must be provided by the legal representative(s) of the minor. In any case, the consents will be collected through a specific form.

In the event of a reservation with the "BeSafe Rate Rate", your personal data (name, surname, e-mail, start and end date of stay) will be processed in order to allow **the activation of the "BeSafe Rate Rate" Service and the related policy insurance, also allowing the provision of preparatory and consequent services.**

The legal basis of the treatments indicated above is identified in the execution of a contract of which the interested party is a part or in the execution of pre-contractual measures adopted at the request of the same (art. 6.1.b of the Regulation).

We also inform you that the data collected and provided by you may also be related to your family members / companions.

The provision of your Personal Data for the aforementioned purpose is optional, but in the absence of such data it will not be possible to proceed with the management of the availability check and send the booking request.

Your Personal Data may be shared with:

- natural persons authorized by the Data Controller to process personal data for the performance of their job duties (e.g. employees and system administrators);
- third parties for carrying out activities related to the management of the reservation and for the possible fulfillment of legal provisions, some of which act as data processors. The complete and updated list of managers is available on the website www.voihotels.com in the Privacy area;
- Insurance companies (in case of booking with "BeSafe Rate")
- subjects, bodies or authorities to whom it is mandatory to communicate your Personal Data by virtue of the provisions of the law or orders from the authorities.

In relation to the indicated purposes, the processing of personal data takes place using manual, IT and telematic tools with logic strictly related to the purposes themselves and, in any case, with methods such as to guarantee the security and confidentiality of the data, in addition to compliance with the specific obligations sanctioned by law.

As regards the possible transfer of data to third countries, the Data Controller announces that the treatment will take place according to one of the methods permitted by current law, such as for example the consent of the interested party, the execution of a contract concluded between the interested party

and the data controller or the execution of pre-contractual measures adopted at the request of the interested party; the conclusion or execution of a contract stipulated between the data controller and another natural or legal person in favor of the interested party; the adoption of Standard Clauses approved by the European Commission, the selection of subjects operating in countries considered safe by the European Commission. It is possible to obtain further information, upon request, from the Data Controller at the contacts indicated above.

Your Personal Data will be kept only for the time necessary for the purposes for which they are collected, respecting the principle of minimization referred to in article 5, paragraph 1, letter c) of the GDPR. In any case, your personal data will be kept for the time necessary to perform the services provided for in the contract. In any case, the further conservation envisaged by the applicable legislation is reserved, including that envisaged by art. 2946 code civ. Further information is available from the Owner.

You have the right to ask the Data Controller, at any time, for access to your Data, for rectification or cancellation of the same or to oppose their treatment, to request the limitation of treatment, or to obtain in a structured format, for use common and readable by automatic device the data concerning you in the cases provided for by art. 20 of the Regulation.

You can revoke the consent already given at any time, pursuant to art. 7 of the Regulation, without this affecting the lawfulness of the processing carried out prior to the withdrawal of consent.

In any case, you always have the right to lodge a complaint with the competent supervisory authority (Guarantor for the Protection of Personal Data), pursuant to art. 77 of the Regulation, if you believe that the processing of your data is contrary to the legislation in force.
